### OSNOVNI PODACI O NAČINU I VREMENU ANGAŽOVANJA:

**Vrsta angažovanja:** Ugovor o delu.

**Period angažovanja:** pet meseci, okvirno od sredine januara do sredine juna 2023. godine, u skladu sa dinamikom realizacije projekta, navedenom u prilogu.

**Rok i način plaćanja:** plaćanje za obavljeni posao se vrši uplatom avansa u iznou od 50% nakon potpisivanje ugovora i uplatom preostalog iznosa sredstava na bankovni račun konsultanta 10 dana nakon kompletne obavljenog posla odnosno predatog završnog izveštaja.
